After spending 26 years at sea, 12 of which as Master on a wide range of ocean-going vessels ranging from gas carriers, tankers to ferries and cape-sized bulker carriers, Mr David Heaselden came ashore and joined the UK P&I Club as a ship inspector in 1997. David's job scope required him to travel widely to visit and report on the condition and management of hundreds of vessels of all types.

Four years later, David joined the Shipowners' Club as Loss Prevention Manager and was in charge of loss prevention initiatives and the Ship Inspection Programme. In April 2009, David was transferred to the Singapore branch office and assumed responsibility for the management of the office function as well as the running of the Loss Prevention Department.

In July 2011, David was appointed Loss Prevention Director. David enjoys swimming and exploring Singapore by foot during his spare time.

Ms Gillian Musgrave obtained her law degree at the Southampton University in 1986 and qualified as a solicitor in 1990. Gillian joined the Standard Club, London, syndicate B in 2000 and returned to private practice at Ince & Co, London a year later. In 2004, she re-joined Standard Club to work in the New York office and subsequently moved to the Piraeus office in April 2006, where she assumed responsibility as Regional Claims Director. In May 2010, Gillian joined the Singapore office where she heads as the Regional Claims Director.



Presentation topic: Demystifying P&I Clubs

The upcoming Maritime Knowledge Shipping Session will debut its first; a session whereby both presenters will cover one presentation jointly, titled, *Demystifying P&I Clubs*.

In the first half of the presentation, both speakers will seek to provide participants with an overview of the role of P&I Clubs and the cover they provide to their members, namely ship owners, operators and charterers. They will also shed some light on how the cover provided by P&I Clubs complement other types of marine insurance and the functions of the various departments within P&I Clubs. Participants will gain insights to how marine mutual third party liability insurers, such as the P&I Clubs, function and what benefits their members enjoy.

What constitutes large claims and how are these claims dealt by different companies? How would the different stakeholders and agencies react to such claims? In the second half of the presentation, both speakers will use a case study to illustrate intricacies of large claims and discuss key issues that may be pertinent to the varied stakeholders that are involved. The speakers will also provide participants with a well-rounded understanding of the content shared in the earlier half of the presentation.
