Vehicle Accident Report History (VARH)

Frequently Asked Questions



1. Can I purchase a report if I'm not the owner of the vehicle?

No, the report for a vehicle can only be purchased by the registered owner at the time of purchase according to Myinfo records.

2. How much does the report cost?

The cost of each report is S\$90 plus prevailing GST.

3. Can I purchase a report if the owner of the vehicle is a company?

At the moment, corporate vehicle owners are not able to purchase a report. We are working to allow purchases by corporate owners in 2024.

4. What details will be included in the report?

Key details include:

- Date and Time the report was generated
- Vehicle Registration Number
- Chassis Number of Current Vehicle
- First registration date (when the vehicle was first registered with LTA)
- Vehicle Make and Model
- Date of accident
- Date of accident report submission

Please refer to Appendix A for a sample report.

5. Can I purchase a report if I don't have Singpass?

At the moment, you must purchase the report with a valid Singpass account. We are considering options on how to deliver the function without verified identity information from MyInfo.

6. Can I purchase a report if my vehicle number was transferred from another vehicle?

Yes, you can. As long as at the time of purchase, MyInfo records show that you are the registered owner of the vehicle.

7. Can I look up accidents that may have occurred more than 6 years ago?

The report shows the history of accident reports made by owners or drivers of their vehicles for the past 6 years.

Hence accidents that occurred more than 6 years ago can be found in the report if the original accident report or any subsequent addendum for the accident has been submitted through the GEARS platform within 6 years from the date of the request.

8. What mode(s) of payment are accepted?

PayNow and Credit Card.

9. I would like to purchase the accident report history for the different vehicles that I own. Can I do so in one transaction?

Each transaction will allow for the purchase of the accident report history for one vehicle. The buyer will have to pay the fee for each transaction/purchase made.

10. How is this different from GIA Record Management Center's (GIARMC) Third Party Accident Report purchase?

The GIARMC Third Party Accident Report purchase allows vehicle owners or drivers to purchase the Accident Report of another vehicle (the Third Party), provided that your vehicle was involved in the same accident. This report is mainly used for motor insurance claim purposes.

The Accident Report History report provides the history of Accident Report(s) submitted for a vehicle if you are the registered owner of that vehicle at the time of purchase.

11. If I lose the initial copy of the report, can I redownload the report again?

No. You will need to purchase the report again.

12. Can I send the report to multiple email addresses?

No. The report will be sent to the email address in Myinfo records by default. If the email address is outdated, you will have the option to indicate a different email address for the sending of the report, at the point of application.
